It is Holder's Country Inn on 998 S De Anza Blvd, San Jose. Phone is (408) 517 0996. We meet on Tuesday, August 24th starting at 11:30 for social time and lunch at 12:00. The BEC meets there at 10:00 AM.

We have our own separate room which seats 82 members. The tables will be placed in a horseshoe with the speaker's podium at the front.

The menu will include a choice of 4 entrees which are ; sea bass, new york steak, chicken parmesan or yankee pot roast (menu changed monyhlly with the same high quality choices). Soup or a large salad to begin the meal with any kind of a drink included (ie milk, choclolate milk, lemonade, iced tea, coffee, orange juice, with refils). There is a bar for alcoholic sustanence but you have to pay for that. No dessert but the tip is included in the price, which is \$28.00.. 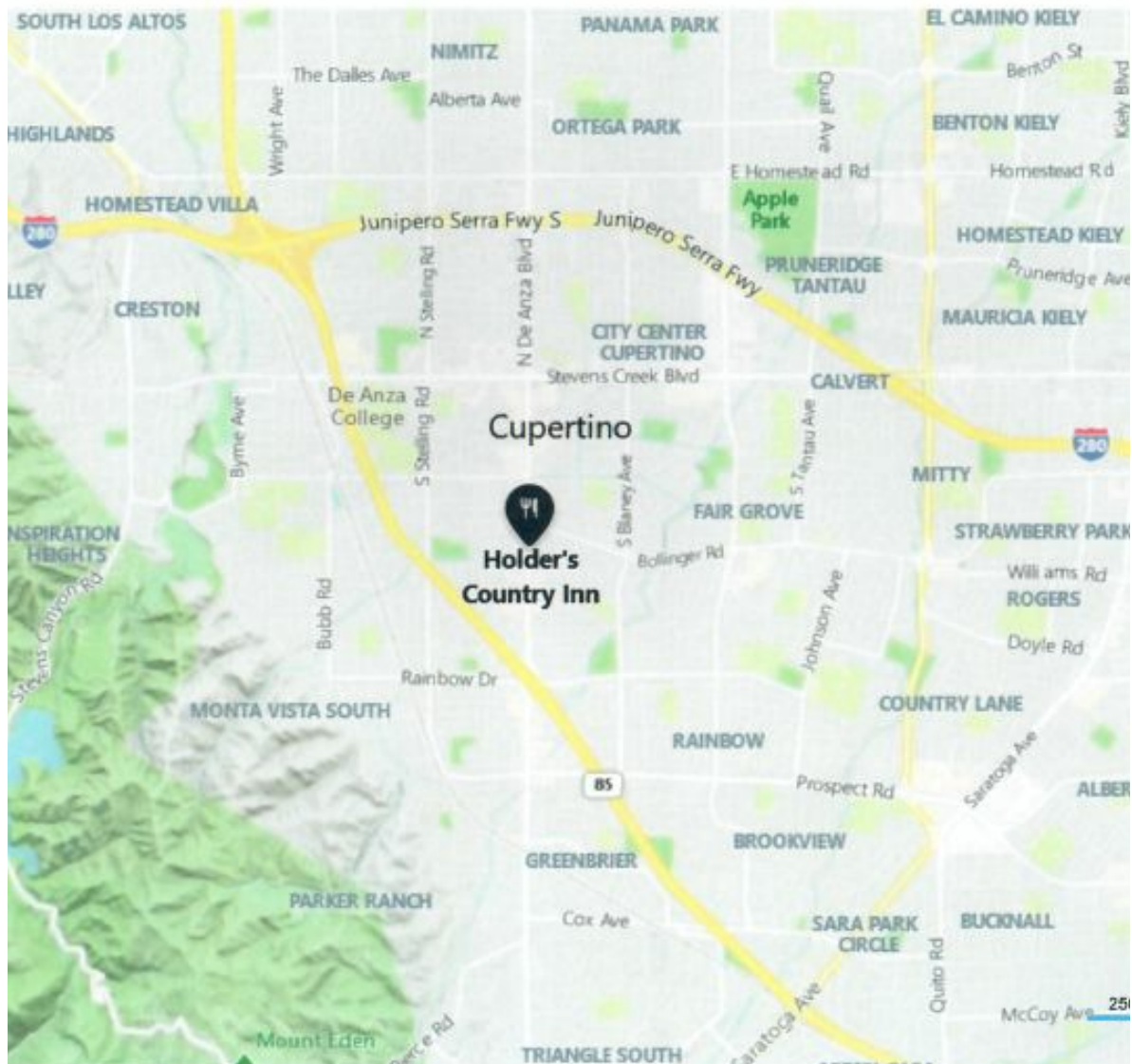
